This is the Trustees' Report and Financial statements for the year ended 31 December 2017. It is presented in accordance with current statutory requirements, the requirements of the Charity's governing document, the provisions of the Charities Act 2011 and the Statement of Recommended Practice applicable to the Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS 102) - (Charities SORP (FRS 102)).

CHAIRMAN'S REPORT

Dear Friends,

Our strap line Helping Caring Giving reflects who we are and what we do. 2017 has been no exception and I would like to give you a brief overview of what you have achieved this year.

Helping and Caring

We have around 120 volunteers who come in either every week or every other week to help in the hospital. Most volunteers stay with the same department, but others work across a few departments and some also help out when we are short on a rota schedule. When I see volunteers interacting with patients, staff and visitors and helping make their visit a better one by changing the flowers on the wards, taking them to their appointment or simply stopping to have a chat, that is where we are Helping and Caring every day of every week here at The Royal Marsden, Chelsea.

Giving

All our sources of income are important to us and further details are set out overleaf.

We do have to fund raise, and this year began with a charity tea for an Open Garden Day at Dunsborough Park, near Ripley, Surrey. This was followed by our ever-popular biennial Summer Garden Party at The Chelsea Gardener in May, our annual Quiz Night in October and the annual Festival of Carols in early December together with The Royal Brompton and Chelsea and Westminster Hospitals. Nick Fellowes, the husband of volunteer Henty, and his friend Bill Lord, cycled The London100 Prudential Bike Ride and raised over £15,000. This directly funded a refurbishment of the day rooms on Horder Ward including a new bespoke children's area.

We funded the purchase of items of equipment including a portable ultrasound for the Head and Neck Department, an Ultrasound for Radiology, a second Blood Analyser for the Critical Care Unit and Genetic Testing Equipment for Pathology. We refurbished the existing roof terrace and a new lower terrace, funded Well Being events, free beverages for patients undergoing radiology and Christmas presents for all patients staying in over the Christmas period.

None of the above happens without our volunteers so this is a big thank you from me. On a final note, the Young Friends got off to a flying start this year with a very successful Quiz Night and they have more events planned in 2018. I know that all of us "Old Friends" wish all our Young Friends every success and that together, we will all continue to volunteer, support and fund raise to help The Royal Marsden, Chelsea.

Five days a week, 52 weeks of the year, volunteers work in the hospital, serving in the Shop and Café as well as in several other departments around the hospital.

The volunteers number almost 200, some of whom have dedicated their efforts to The Royal Marsden for over 20 years.

Together in 2017 the Shop, Shop trolley and Café contributed £50,000 to the hospital.



The Friends' Café

The Café, in The Outpatients Department, first floor Wallace Wing, is open Monday to Friday from 10.00 am to 4 pm. We need a minimum of nine volunteers every day, all of whom have undergone additional health and safety training to help run the Café.

Patients, their friends and family and staff can choose from freshly made sandwiches, home-made cakes as well as gluten free foods and the introduction of healthier snacks following input from and discussions with the hospital.

The Café is an important catering service for patients, their family and friends at the hospital. In addition, all profits from the Café are returned to the hospital to fund the provision of equipment and services which in 2017 amounted to over £31,000.

The Friends' Shop

The Shop is situated to the left of Main Reception at Fulham Road and is open from 10.00 am to 3.45 pm every weekday.

It sells greeting cards, seasonal cards, newspapers, magazines, stamps, confectionery and a range of carefully selected healthier snacks. There is a small range of gifts handpicked by one of our volunteers. It also sells a range of essential items for patients such as toothbrushes, toothpaste, soap, deodorant, tissues and shaving items. There is a large chiller cabinet for cold drinks and milk.

As well as being an important service for patients, their visitors and staff, all profits from the Shop and Shop Trolley are returned to the hospital. In 2017 this amounted to over £17,000.



Volunteers at The Royal Marsden, Chelsea work both indoors and outdoors, nurturing the garden, tending the flowers and taking the Shop and Hobbies trolleys to the patients' bedsides. The award winning garden is a particular haven offering a retreat to all in fine weather.



The Shop Trolley

Two volunteers are required to take the shop trolley around the wards which happens twice a day Monday to Thursday and Friday mornings. It is a relatively large trolley and the volunteers make every effort to put as many items from the shop as possible for patients to choose from including newspapers, magazines, soft drinks, confectionery, snacks, gifts and essentials items.

The Trolley is a welcome part of the hospital routine each day for many patients. As well as providing a service, the funds from the Shop Trolley, along with those from the Shop are returned to the hospital.

The Hobbies Trolley

The Hobbies Trolley goes around the wards four times every week and sometimes also on a Saturday when a volunteer is available. The trolley stocks a variety of games, puzzles, jigsaws and books for patients to choose from. It makes a small profit, but it is a service we like to offer to patients during their stay at the hospital.

Flowers

The Royal Marsden, Chelsea is one of few London hospitals that allow flowers for patients on the wards. There are fourteen volunteers and they come in on a rota basis three days every week to check and tend to the flowers. This helps staff and patients while also enabling interaction between patients and the volunteers, while carrying out their duties.

We are very grateful to OKA for their generous donation of seasonal silk flowers in several reception areas of the hospital.

The Terrace

In 2017 we refurbished the roof terrace by replacing garden furniture with new benches. chairs, tables and containers. We also designed and funded a new lower terrace including artificial turf, new tables and chairs, steel containers and a professional irrigation system. This has more than doubled the seating area so that patients and staff can enjoy some time outside in a peaceful and natural environment. Friends plant and maintain both terraces, together with the various pots around the hospital and the terrace outside the Critical Care Unit.

During 2017, we estimate that the Friends contributed nearly 20,000 hours of their time to the hospital.

Volunteers come from all walks of life and bring with them all sorts of different experience but, whether helping on the wards or around the hospital they are united in their wish to make a positive difference to the experience of patients, visitors and staff at the world-class Royal Marsden, Chelsea.



Assisting in Horder Ward

Volunteers who help on Horder Ward, 5th floor Granard House come in every weekday lunchtime and evening to help the catering staff prepare and serve the lunchtime and evening meal. Please see the section on Events and

Fundraising as the sum of over £15,000 was raised and used to improve the communal rooms on Horder for the benefit of patients and their families including a new children's area and two additional rooms for use as a TV room and an additional sitting room. This was organised by Henty Fellowes with the support of Gemma Kane, the Matron of Horde, along with the support of staff and volunteers on the ward.

Magazines & Books

Volunteers and supporters donate good quality second hand hardback and paperback books to us on a regular basis which we resell in the Outpatients Café, the Shop and the Medical Day Unit.

Condé Nast Publications provide quality magazines to us free of charge for distribution within the various reception areas within the hospital.

Meet & Greet

Volunteers are on hand at Reception from 10.00 am to 3 pm every weekday and also from 8.30 am to 10.00 am on Mondays and Wednesdays. A volunteer will escort patients to appointments within the hospital when requested by the patient or by Reception to do so. It is a friendly face on hand to help and show them where a department is situated and the easiest way to get there.

Meet and Greet volunteers also also run a daily tea trolley service, Monday to Friday, serving complimentary tea and coffee to patients and their carers in the Medical Day Unit.

Outpatient Support

The Outpatients Department, together with The Medical Day Unit, is one of the busiest departments in the hospital and volunteers are on hand between 10.30 am and 3.30 pm to help patients where they can.

Volunteers also supply hot drinks to the busy clinical staff in the department from the Outpatients Cafe.

Recruitment

To become a volunteer, there is an interview with our Recruitment volunteer in our office. Personal references are requested together with an annual subscription.

Following acceptance, volunteers undergo standard training required by the hospital together with any further training that may be required which is dependent on the department in which the volunteer will be working.

In 2017, we began implementing DBS (Disclosure and Barring Service) checks on all existing and new volunteers at the request of the hospital. It is anticipated that this will be complete for existing volunteers early in 2018.

Newsletters

A quarterly newsletter is distributed to all volunteers updating them on fundraising events and general information.

Christmas Day

Gifts are distributed by volunteers to all in-patients on Christmas Day morning.

The Festival of Carols

This is a popular event held annually at Holy Trinity, Sloane Square. It is organised in collaboration with The Royal Brompton and Chelsea and Westminster hospitals.

Celebrate a Life

The Friends support The Royal Marsden's 'Celebrate A Life' Christmas service. For the past two years, the event has been sponsored by the 'Event Factor' who very kindly donate mulled wine and mince pies for volunteers to distribute amongst all attendees.

Public Benefit

The activities described on pages 6-9 clearly benefit The Royal Marsden hospital and its patients. The Trustees have also had regard to the Charity Commission's guidance on public benefit.

EVENTS & FUNDRAISING

Events and Fundraising is vital to the work of the Friends. Thanks to the hard work and efforts of volunteers, supporters and benefactors the Friends can continue to support the hospital in many ways, not least with volunteers but also with funds that simply otherwise would not have been available.



Summer Drinks Party

Once again, our biennial Summer Drinks Party at The Chelsea Gardener on Sydney Street proved

Gardener on Sydney Street proved as popular as ever and on a warm evening in May over £26,000 was raised for The Friends. The event was very generously sponsored by Rathbone Investment

Management, who also supplied all guests with a goody bag.

Prudential Bike Ride

Nick Fellowes and his friend Bill Lord raised over £15,000 for the Friends by cycling over 100 miles on 2 consecutive days. The money raised directly funded the

refurbishment of the Day Room on Horder Ward including a bespoke children's area with new shelving and display areas together with new toys and books.

There was enough money left to fund a new TV room for patients to watch films with their family and the refurbishment of an additional informal sitting room with sofa beds. Henty, Nick's wife and a volunteer on Horder, helped to organise and implement the refurbishment works with input from the staff on Horder.

Other Events

We were invited to provide tea and cake at an annual Open Day at Dunsborough Park near Ripley, Surrey in April which is a new event for us and which raised over £1,000. Our volunteers rose to the challenge and provided cakes, sandwiches and biscuits for us to sell on the day.

Our annual Quiz Night in October was as competitive as ever and The Young Friends also ran a Quiz Night, raising over £1,000.

We were also given a stand at the entrance to the Christmas Grand Sale at The Horticultural Halls in November and in early December we held our annual Festival of Carols.







SUBSCRIPTIONS & DONATIONS

Generating income is an important part of the Friends role and while volunteers give their time, the Friends are equally supportive by paying their subscriptions. This, on top of donations, legacies and other income streams ensure the work of the Friends continues apace at The Royal Marsden, Chelsea.





was raised from Friends donations and subscriptions. This represents almost half of the Friends' net income.

Subscriptions & Donations

During 2017, Subscriptions and Donations contributed over £27,000 and £51,000 respectively while donations in memory of loved ones contributed over £2,000.

Volunteers

Each weekday, volunteers help in the Café, Shop, on Horder Ward, Meet and Greet, Flowers, Shop and Hobbies Trollies and the garden. In addition there is a list of volunteers who are happy to help out at short notice if there is an unexpected gap in the rota.

Every volunteer is required to attend and complete induction training and ongoing training in accordance with the requirements of the hospital.

In 2017, we estimate that around 20,000 hours of unpaid help and support was given, by volunteers, to the hospital.

Charity Collection Tins

Collection tins in the hospital and local retail outlets raised over £16,000, including the sum raised by Eaton House School Belgravia at their outdoor Carol Concert in Sloane Square in December.

Campbell-Paterson Trust

Since 1979 the Friends of The Royal Marsden, Chelsea have been fortunate to benefit from income generated by the late Mrs Campbell-Paterson's Will Trust.

Future Plans

At the end of 2017, the Friends were delighted to agree a three year sponsorship arrangement with Rathbone Investment Management.

A new event for 2018 is Dog Tails in the Park, the first sponsored dog walk in Kensington Gardens, which will take place in May. We are also planning a drinks party in October. Both events will be sponsored by Rathbones.

We have been invited to provide tea and cakes at Dunsborough Park in September and in October, we will be holding our popular Quiz Night in October followed by the annual Festival of Carols in December.

The Young Friends are holding a Spring Ball in March 2018 in Shepherds Bush. This is an exciting development for the future of The Young Friends.

The object of the Friends is "to relieve patients....of the Hospital who are sick, convalescent, disabled, handicapped, infirm....and generally to support the charitable work of the ...Hospital."

To achieve this, our role is twofold. We provide volunteers to help throughout the Hospital where requested (see HELPING GIVING) and we also fundraise to fund the purchase of equipment and the provision of services (see EVENTS AND FUNDRAISING and SUBSCRIPTIONS AND DONATIONS).

At each Committee meeting, a senior member of the clinical staff of The Royal Marsden is in attendance and it is they who provide a prepared wish list of items requested by departments within the hospital.

The list states the amount requested together with a short description of the item or service to be provided. Should the Committee decide more information is required then a decision will be deferred until the following meeting.

There are eight Committee Meetings each year, which take place in February, March, May, June, September, October, November and December. The meetings are held at the hospital at the beginning of each month and all Committee members are expected to attend.

By the end of 2017, the Friends had funded, or committed to, the purchase of equipment and/or services to the hospital in the sum of some £246,750. This breaks down, in percentage terms, to 68% towards hospital equipment, 5% towards videos, 21% towards hospital amenities and 6% towards patient amenities.

FINANCIAL SUMMARY

In 2017, before it paid for any amenities to benefit the hospital and its patients, the net income of Friends of The Royal Marsden, Chelsea was £193,955.

The Table shows that:

- Income from Donations and Subscriptions decreased by 16% due to a smaller number of one-off donations in 2017.
- Income from Legacies and Will Trusts has remained consistent.
- Net income from core activities decreased overall by 13% The Café (-6%), The Shop and Trolley (-5%) and Events (-18%);
- Salary and Support Costs have decreased by 8%.

Reserves Policy

Generally, the Restricted and Unrestricted funds of Friends of The Royal Marsden, Chelsea are available to be spent as the Friends decide, the only exceptions being that:

- The Restricted Funds: The funds provided by the Campbell-Paterson Will Trust must be spent on purchases of medical equipment;
- The Friends have chosen to ring-fence Mrs Rosemary Green's 2013 donation (£56,000) as it was Mrs Green's wish that the funds be used to pay for items that improve the patients' environment. These funds have a remaining balance of £31,000.

After taking the above into account, the Friends of The Royal Marsden, Chelsea does not hold any reserves. However, it does aim to maintain a level of funds, £250,000 at present, that it considers necessary to protect current activities in a way that enables the Charity to meet its responsibilities and to ensure that it continues to operate on a 'Going Concern' basis without risk. The Charity does not consider that it has sufficient funds to initiate any sizeable long term projects. If, however, such a project was to be presented, and deemed suitable, the Friends of The Royal Marsden, Chelsea, would consider amending its reserve policy to fulfill such a commitment.

Structure, Governance and Management

The Friends of The Royal Marsden, Chelsea are governed by the Objects and Rules as amended and altered by the members of the Friends of The Royal Marsden at the Extraordinary General Meeting of the Friends held on 29 November 2007 and effective from 1 January 2008. The Objects and Rules have been amended and re-registered by the Charities Commission on the 6th November 2015. Trustees are nominated by the Committee of the Friends and shall comprise the President of the Friends and a minimum of three members nominated by the Committee for appointment at the Annual General Meeting. The Trustees have delegated the conduct and management of the affairs of the Friends to the Committee in accordance with the Objects and Rules.

Remuneration to Charity Trustees

The Charity paid no remuneration or other benefits in kind to a Charity Trustee.

Relationships with other Charities

The Royal Marsden NHS Foundation Trust has its own fundraising charity which concentrates on major capital projects and the support of research funds. The Trustees of Friends of The Royal Marsden, Chelsea, consider that the income generating activities of their charity, as operated by the dedication of its volunteers, in providing highly visible services, are complementary to the work of the main hospital charity. A significant number of volunteers are recruited from former patients and their families and friends. The Friends of The Royal Marsden, Chelsea meet from time to time with the Friends of other large London hospitals to discuss matters of common interest and to share ideas for providing services and fundraising.

Trustees Responsibilities in Relation to the Financial Statements

The Trustees are responsible for preparing the Trustees' Annual Report and the Financial Statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in England & Wales requires the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Charity and of the incoming resources and application of resources of the Charity for that period. In preparing these financial statements, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently;
- Observe the methods and principles in the Charities SORP 2015 (FRS 102);
- Make judgements and estimates that are reasonable and prudent;
- State whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the Financial Statements;
- Prepare the Financial Statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in operation.

The Trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the Financial Statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the Trust Deed. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The Trustees are responsible for the maintenance and integrity of the charity and financial information included on the Charity's website. Legislation in the United Kingdom governing the preparation and dissemination of Financial Statements may differ from legislation in other jurisdictions.

Independent Auditor's Report to the Trustees of Friends of The Royal Marsden, Chelsea

Opinion

We have audited the financial statements of Friends of The Royal Marsden, Chelsea for the year ended 31 December 2017 which comprise of the Statement of Financial Activities, the Balance Sheet, and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

This report is made solely to the charity's trustees, as a body, in accordance with Part 4 of the Charities (Accounts and Reports) Regulations 2008. Our audit work has been undertaken so that we might state to the charity's trustees those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the charity and the charity's trustees as a body, for our audit work, for this report, or for the opinions we have formed.

In our opinion the financial statements:

- give a true and fair view of the state of the charity's affairs as at 31 December 2017, and of its incoming resources and application of resources, for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Charities Act 2011.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the charity in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, including the FRC's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Conclusions relating to going concern

We have nothing to report in respect of the following matters in relation to which the ISAs (UK) require us to report to you where:

1. Accounting Policies

The principal accounting policies adopted, judgements and key sources of estimation uncertainty in the preparation of the Financial Statements are as follows:

1.1 Basis of Preparation

The Financial Statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), and the Charities Act.

Friends of The Royal Marsden, Chelsea meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).

The Charity has applied Update Bulletin 1 as published on 2 February 2016 and does not include a cash flow statement on the grounds that it is applying FRS 102 Section 1A.

1.2 Fund accounting

Unrestricted Funds are funds that are available for use at the discretion of the Trustees to advance the general objectives of the Charity and that have not been designated for other purposes.

There is one Restricted Fund, the WL Campbell-Paterson Will Trust, under which the Friends of The Royal Marsden, Chelsea are required to use all income from the Trust to provide medical equipment to The Royal Marsden NHS Foundation Trust. However, with the consent of the Charity Commissioners, the Friends of The Royal Marsden, Chelsea have agreed that Mrs Barbara Marriott, the only daughter of the deceased, should receive, during her lifetime, one quarter of the net income received from the WL Campbell-Paterson Will Trust by the Friends of The Royal Marsden, Chelsea. Also ring-fenced but still held in unrestricted funds is £31,000, which is the amount remaining of the £56,000 donation Mrs Rosemary Green made in 2013. These funds are earmarked for spending that will directly benefit the well-being of the patients.

1.3 Accounting policies

INCOMING RESOURCES: All incoming resources are included in the Statement of Financial Activities when the Friends of The Royal Marsden, Chelsea are entitled to the income and the amount can be measured with sufficient reliability. Legacies are included when the Friends are advised by the personal representative of an estate that payment will be made or property transferred and the amount involved can be quantified.

Where incoming resources have related expenditure, as with fundraising, the incoming resources and related expenditure are reported gross in the Statement of Financial Activities.

Donations are only included in the Statement of Financial Activities when the Friends of The Royal Marsden, Chelsea have unconditional entitlement to the resources.

Incoming resources from tax reclaims are included in the Statement of Financial Activities at the same time as the gift to which they relate.

Donated services and facilities are only included in incoming resources, with an equivalent amount in resources expended, where the benefit to the Charity is reasonably quantifiable, measurable and material. The value placed on these resources is the estimated value to the Charity of the service or facility received.

The value of any voluntary help received is not included in the accounts but is described in the Trustees' Annual Report. Investment income is included in the accounts when receivable.

RESOURCES EXPENDED: All expenditure is accounted for on an accrual basis and included under expense categories that aggregate costs for allocation to activities. Where costs cannot be directly attributed to particular activities, they have been allocated on a basis consistent with the use of the resources.

VALUE ADDED TAX: Income and Expenditure are shown net of recoverable VAT.

ASSETS: Tangible fixed assets are capitalised if they can be used for more than one year and cost more than £500. They are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following basis: Café equipment - 25% straight line over four years. Stocks are valued at the lower of cost or market value. Trade and others debtors are recognised at transaction price.

CREDITORS: Creditors are recognised at transaction price.
